

HOW TAX CREDIT MONIES CAN PAY FOR THE CALIFORNIA TRIP!!!!

Donate 2009 Arizona tax credit monies to the Rincon/UHS Band and 75% of the contribution will offset your child's cost for the California trip. The remaining 25% will fund Rincon/UHS Band Department expenses for such things as music, marching drill, and licensing fees, and instruments and instrument repairs.

HERE'S HOW IT WORKS:

Example: If you are a married couple filing a joint return, you can receive a tax credit of up to \$400. \$300 will be applied to your child's cost for the trip. The remaining \$100 will go toward the Band Department's operating expenses. Single individuals can receive a tax credit of \$200, with \$150 credit toward the trip and \$50 to the Band Dept. All tax credit donations are non-refundable.

HERE'S WHAT TO DO:

Pick up the pink TUSD Tax Credit slip in the Rincon/UHS finance office, or print it off the TUSD website, or donate online:

FILL OUT THE TUSD TAX CREDIT SLIP AS FOLLOWS:

- **School:** Rincon High School or University High School
- **Activity:** Fine Arts
- **Activity Description:** Band Department
- **Amount you are donating**
- **Comments:** California Trip + name of student

PRINTED FORMS: Deliver your TUSD Tax Credit slip and check donation to either Mr. Wolfe or the Rincon/UHS Finance Office. **In addition, you must submit to Mr. Wolfe RUMBA's separate California Trip Credit form** (see "Forms" on our website or pick one up on the piano in the Band Room). This separate form is required to expedite verification of trip credit for your student.

ONLINE PAYMENTS: Follow the TUSD tax credit slip selection process above. **In addition, you must submit to Mr. Wolfe RUMBA's separate California Trip Credit form.** Verification of online donations and those sent directly to TUSD or the school office are required before trip credit can be applied. RUMBA's "in-house" *Trip Credit* form helps expedite accounting for specific student/s, especially when the donor is other than a parent.

Any Arizona taxpayer is eligible to participate in the School Tax Credit program.

*NOTE: If you already donated after January 1, 2009,
that tax credit cannot be applied to the California trip.*

*RUMBA's California Trip Credit form must be submitted to Mr. Wolfe
for accurate accounting of trip credit.*
